At the onset of the meeting the Registrar, TVC has extended heartiest welcome to every participant in the meeting on behalf of the TVC and initiated agenda wise discussion. Welcoming all the member, President TVC opened the discussion and after a detailed discussion the following decision were taken:

- Ex-post facto approval for expenditure incurred for purchase of Mask / Hand Sanitizer etc. for Veterinarians amounting to Rs. 72,998/- done by Kobrakhamar Anchalik Lamps Ltd: the house unanimously accorded the approval and sanction of Rs. 72,998/- for in favour of Kobrakhamar Anchalik Lamps Ltd. in connection with supply of Mask/ Hand Sanitizer etc. for Registered veterinarian.
- 2. Purchase and distribution of Mask / Hand Sanitizer etc. for field Para vets. and Group-D Staffs: As decided in the meeting one time mask @ 5 Nos. and @ 2 nos N-95 mask will be provided to all field para-vets and Group-D staffs. The number will be assessed after discussion with the Dy. Director of ARDD, Estt. Section, Directorate of ARDD. It was also decided that Mask and hand sanitizer will be provided to the RVP posted at Directorate, Senior Practicing Vets, Internee Vets. etc.
- 3. Development of online election facility in the State for election of State Veterinary Council: After detail discussion on the issue the house opined to communicate the issue with the state Government since the tenure of the present Council is going to end by November, 2021. Registrar TVC will take up all necessary initiative in connection with the issue.
- 4. Formation of disciplinary committee: Letter received from the President, VCI regarding formation of Disciplinary Committee as per regulation 43 of "Standard of Professional Conduct, Etiquette and Code of Ethics for Veterinary Practitioner Regulation 1992" framed by VCI under Section 31 of Indian Veterinary

Council, Act, 1984 was discussed in the meeting. As per advisory of the President VCI, State Veterinary Council should develop a suitable platform for receiving complaint of professional misconduct through online and shall expeditiously disposed off such complaint within a time frame of 45 days from receipt of such complaint. Accordingly, it was decided to form a disciplinary committee in Tripura Veterinary Council for dealing with aforesaid matters so that Provision of IVC act and Regulation could be implemented in the state with the following Registered Veterinary Practitioner of the Council:

- iv) Dr. Bikash Chandra Debnath, SVP Regn. No.142, Asstt. Professor, College of Vety. Science, R. K Nagar- Member.
- v) Dr. Jeshmin Debbarma, SVP Regn. No. 96 Asstt. Director of ARD- Member.
- 5. Continues Veterinary Education programme at College of Veterinary Sciences and Animal Husbandry and adjustment of fund provided: It was decided to request Principal, C.V.Sc. & AH, R K Nagar to conduct rest of the programme of CVE as early as possible and submit the UC/adjustment of the fund placed for the purpose amounting to Rs.2.10 Lakh.
