**Sub: Election of members of Council for formation of new body of Tripura Veterinary Council (TVC) for the period of May, 2025 to April, 2028-reg.**

As per provision of Rule 9(1) and Rule 9(2) of Tripura Veterinary Council Rules, 2000, the following officers of Animal Resources Development Department, Government of Tripura are hereby appointed as "Returning Officer" and "Assistant Returning Officer" for the purpose of conducting election in respect of formation of new body of Tripura Veterinary Council for the period of May, 2025 to April-2028.

Further the appointed officers may also follow the procedure of conducting election to TVC as per TVC Rules-2000, i.e.

1. Notification for election to the Council.
2. Preparation of the electoral roll by the Registrar, TVC.
3. Publication of draft electoral roll by the Registrar, TVC.
4. Period of lodging claims and objections (30 days from the date of publication of draft electoral roll) by TVC.
5. Publication of final electoral roll by the Registrar, TVC.
6. Declaration of dates for nomination etc. by the Returning Officer.
7. Scrutiny of nomination papers by the Returning Officer.
8. Withdrawal of nomination by candidates under supervision of the Returning Officer.
9. Publication of the list of contesting candidates by the Returning Officer.
10. The Poll under supervision of the Returning Officer.
11. Scrutiny and counting of votes by the Returning Officer.
12. Intimation of results of election to the State Government by the Returning Officer.
13. Publication of the names of elected candidates in the Official Gazette by the State Government.
14. A convenient date of poll may be fixed keeping in view at least a period of 60 (sixty) days approx. will be required to complete the election formalities after notification of election.
