

At the onset of the meeting, President, TVC has extended heartiest welcome to every participant in the meeting on behalf of the TVC and requested the Registrar, TVC to initiate agenda wise discussion. Registrar, TVC opened the discussion and the following decisions were taken:


1. World Veterinary Day will be celebrated on 26th April, 2025 at Dasarath Bhavan, Superibagan, Agartala, 2:30 pm onwards in collaboration with Tripura Veterinary Doctor's Association (TVDA). Honorable Minister of ARDD will be invited as Chief guest and Inaugurator, Secretary, ARDD and Director ARDD will be invited as Guest of honor and Special Guest respectively. The Theme of WVD, 2025 is **"ANIMAL HEALTH TAKES A TEAM"** and to commemorate this day several events will be organized which are mentioned below:
 1. **Mega Health cum Vaccination Camp** will be organized at 3 different locations. An amount of Rupees 30000/- (Thirty thousand) only per camp has been sanctioned by the body. The places for camp will be decided by the implementing committee viz. North & Unakoti District, Dhalai District and South & Gomati District.

- Mass Awareness Rally** (Prabhat Pheri) will be organized on 26th April, 2025 at 6:30 am in Agartala which will commence from TVC premises, Astabal.
- Technical Seminar** will be organized on 26th April, 2025, 3:00 pm onwards which will followed by Cultural Programme and Family dinner.

2. Approval of excess amount for professional efficiency development training programme held on 7th March, 2025 at Pragna Bhavan - An amount of Rs 1,00,000/- has been sanctioned by the body to compensate the deficit in PED training programme.
3. Discussion on upcoming election of Tripura Veterinary Council – The election for 4 members of TVC will be held tentatively on May 2025. Necessary process for election will be initiated immediately.
4. Approval for all electric wiring replacement at TVC building – After threadbare discussion the body has decided to collect an estimate from engineer which will be placed in the next meeting for approval.
5. Glow sign board of Tripura Veterinary Council – An amount of Rs. 1,00,000/- (One lakh) only has been sanctioned for making good quality glow sign board of TVC.
6. Illumination of TVC building to commemorate World Veterinary Day, 2025 - An amount of Rs. 50,000/- (Fifty thousand) only has been sanctioned for making illumination of TVC building.
7. Miscellaneous –
 - a. Rs. 2 lakhs has been sanctioned for painting of TVC building.
 - b. Rs 50000/- has been sanctioned for minor repairing of electric wiring and light, fan etc.
 - c. Annual newsletter of TVC will be published every year.
 - d. It has been observed on multiple occasions that the Computer Operator at TVC has exhibited inappropriate behavior towards staff and veterinarians during office hours. Several complaints have been received from both staff members and veterinarians regarding this matter. She has been issued two show-cause notices in the past and, on
